7:15PM PUBLIC HEARING

Supervisor Giunta called the Public Hearing to order at 7:18PM.

**CONSIDERING A CONDITIONAL USE PERMIT FOR CHRISTINE GIGANTE
TO OPERATE WOOF'S CANINE CLUB & INDOOR DOG PARK
AT 135 FEDEX WAY IN A GENERAL INDUSTRIAL (GI) DISTRICT**

The Town Attorney, Dan Schum verified that the Legal Notice was properly published as required by law.

Supervisor Giunta asked if the applicant was present and would come up to speak on this application.

Christine Gigante, 73 Emerald Point, founder of Woofs Canine Club & Indoor Dog Park was here respectfully requesting a Conditional Use Permit for an indoor/outdoor dog park with twenty-four (24) hour access, including the option for entertainment and fund-raising events. Unlike a dog daycare or kennel, this will bring a holistic approach to bring dog families together in social gathering center. Owners will stay and remain present with their dogs. There will be staff (Bark Guards) on duty to supervise, support, monitor, and if necessary clean-up after members and guest. A typical dog family would stay between forty-five (45) minutes to two (2) hours, similar to a gym or children's playground. During peak time, reservations will be required to minimize internal and external traffic for the safety of the dogs and their families and to the neighboring area.

Ms. Gigante went over detailed plans about the Amenities and the Whys of why this is a good idea for Gates. She also presented each Board member with a packet of detailed information including photos, floor plans and mission statement, which is to "Bring dog families together in a safe, fun and holistic way". Their vision "is to change the world one dog park at a time".

Supervisor Giunta asked how big the facility is?

Ms. Gigante replied six-thousand (6,000) square feet interior and an addition of twelve hundred (1,200) square feet exterior

Councilman Loughlin asked about staffing with being open twenty-four (24) hours?

Ms. Gigante the main hours of "staffed" operation will be 7:00AM-10:00PM with possible extended hours. She wants twenty-four (24) hour access. There will be a security guard present Members would have a security code on their phones to open gate and then into the facility

Supervisor Giunta asked how many employees?

Ms. Gigante will start off with four (4) because of the size of the location also depending on the peak hours. Right now, is budgeting nine (900) hundred hours (full-time and part-time)

Councilman Tucciarello asked if that's four (4) at any one time, but as time goes on, would she hire more staff?

Ms. Gigante responded yes, possible ten to twelve (10-12) more employees

Supervisor Giunta asked how many dogs, especially in peak hours?

Ms. Gigante, in peak hours can max seventy-five (75) dog families. Need to allow as little as seventy-five (75) square-foot per dog family up to one-hundred and twenty-five (125) square feet per dog family. When the weather is nice and doors are open, this opens the capacity as well.

Supervisor Giunta asked if she plans to offer trainings or some sort of school?

Ms. Gigante haven't said No nor Yes to it. They want to partner up with other business, such as working with the community, hosting events and have food trucks, which would help them as well

Councilman Cordero asked is she would charge a trainer for space?

Ms. Gigante, a minimal fee for a trainer is want to be there, the walls a moveable, so they would be separate from the others.

Attorney Schum asked if people will be able to drop off their dog and leave?

Ms. Gigante, No the purpose is to play or workout together.

Attorney Schum asked if the dogs have free run and what about aggressive dogs vs non aggressive?

Ms. Gigante, yes, it's off-leash and all must be vetted. If there is a dog with a special circumstance, the walls are portable and would allow space for them to utilize, if available.

Supervisor Giunta asked if there will be a kennel and in the Town of Gates it's required that every dog be licensed and wants to know if they'll be checking?

Ms. Gigante, No kennels, they are about togetherness. They will check for proof of licensing and vaccination.

Attorney Schum asked if they will build an outdoor dog run and about the fencing?

Ms. Gigante, it's already an open space with ten (10) foot high fence

Supervisor Giunta asked if anyone in the audience had additional comments, hearing none closed the public hearing.
